



# Lippo Securities Limited

## Supplemental to the Cash Client's Agreement - Internet Services Agreement

**THIS SUPPLEMENTAL AGREEMENT** is made the \_\_\_\_\_ day of \_\_\_\_\_ between Lippo Securities Limited whose respective registered office is situated at 2302, Tower One, Lippo Centre, 89 Queensway, Central, Hong Kong of the one part and the Customer whose name(s), address(es) and description(s) are set out in the Schedule to the Cash Client's Agreement (as hereinafter defined) of the other part.

### **WHEREAS:**

This Supplemental Agreement is supplemental to the Cash Client's Agreement dated \_\_\_\_\_ entered into between Lippo Securities Limited of the one part and the Customer of the other part.

### **NOW IT IS HEREBY AGREED as follows:-**

1. You will provide me/us with Internet Services ("IS") in accordance with the terms of this agreement as modified by you and notify to me/us from time to time.
2. I/We agree to accept responsibility, as the only authorized user, for the confidentiality, protection, security and use of access codes issued by you to me/us and not to reveal them to any other person.
3. I/We acknowledge and agree that we are wholly and solely responsible for all orders and instructions entered through IS. We undertake not to attempt to tamper in any way or gain unauthorized access to any part of the IS or its related website and software. I/We undertake to inform you at any time that I/We believe or suspect that any third party engages in activities described in this paragraph.
4. I/We acknowledge that you may close my/our account immediately without notice for any reason you, in your absolute discretion, deem fit.
5. No trading will be permitted in the account unless sufficient cleared funds are available to settle the transaction to your satisfaction.

6. You will not be deemed to have accepted any instructions from me/us until you have acknowledged receipt of any such instructions.
7. As a condition of using the IS, I/We agree to immediately notify you if:
  - After placing instructions I/We receive no acknowledgement
  - I/We receive acknowledgement of any instructions that I/We did not place;
  - I/We encounter any difficulties or problems with IS;
  - I/We lose my/our SIM card;
  - I/We become aware of any activities described in paragraph 3 above done by any third parties;
  - I/We become aware of any unauthorized use of my/our account or access codes.
8. I/We acknowledge the essential importance of exercising care when entering orders or placing instructions as, once given, instructions may not be able to be cancelled.
9. I/We agree that you shall not be liable for any loss or damage incurred by me/us or any other party in using or attempting to use IS unless such loss or damage is caused by willful default or gross negligence on your part.
10. I/We acknowledge that various exchanges and other entities may assert proprietary rights over market data and that I/We will not infringe any such rights.
11. I/We acknowledge that market data and news cannot be guaranteed as to accuracy and timeliness and that you will not be liable in any way for any such deficiencies.
12. I/We acknowledge that by undertaking to transact over the internet I/We accept all risks of corrupted or failed communications, whether due to hardware or software failure or improper and/or fraudulent access to and or use of my/our account. I/We accept and understand that such failures can be due to traffic congestion or malicious interference by unknown parties.
13. I/We undertake to provide and maintain at my/our cost and risk all equipment such as personal computers and modems for access to IS.
14. I/We acknowledge receipt and our understanding of the suggested security measures. I/We acknowledge that it is my/our sole responsibility to keep up to date with constantly evolving security threats.

**Risk Disclosure and Security Warning**

The very fact that you are looking at an Internet Broking Site indicates that you have a certain familiarity with the advantages of the Internet and are perhaps drawn to the perceived convenience and cost benefits.

However we must warn you that the Internet is inherently insecure and subject to technical failure. Not just our site but any site is subject to potential hacking that may violate the safety of private information as well as financial assets.

Whilst we employ such things as firewalls and recommended encryption and take very seriously our responsibility to protect your privacy and assets, we cannot absolutely guarantee this. For example your own personal computer is subject to possible security attacks from viruses and Trojans that can pick up financial data, pin numbers and codes allowing third parties to steal or divert data and financial assets such as cash or securities.

You should change your pin numbers and passwords from time to time. You should use software, such as Norton Anti Virus and Spybot or other proprietary programmes designed to protect your computer. You should run these frequently even daily. We cannot accept responsibility for the security of your computer system.

You should monitor your account and advise us immediately should you notice any discrepancy in your account. This is for your protection as well as ours.

Please understand that we believe that the above warning is applicable to any commercial transactions on the Internet not just dealing with Lippo but other brokers, banks, even retailers such as bookshops, music stores and airlines etc involving money transfers and credit card payments.

Please understand that this warning cannot be comprehensive as new criminal schemes such as phishing and identity theft keep evolving.
